The records of Lully's Inc. d/b/a The Right One ("The Right One") indicate that you are a member of a proposed Class (defined below) of persons who paid monies to The Right One for services during a certain time period. As explained in the accompanying Notice of Settlement of Class Action Claims (the "Notice"), the Class Representatives in the above-referenced case allege that The Right One and certain of its shareholders and related entities are liable to the Class for actual and punitive damages. Subject to Court approval, the parties have reached a settlement whereby The Right One will contribute a total of \$200,000.00 in return for, among other things, complete extinguishment of all claims, known and unknown, matured and unmatured, based upon or arising out of the claims made against The Right One. For more complete details of the settlement, please see the Notice of Class Action Settlement that is on file with the Court.

To recover from the fund created by the settlement, you must complete this Proof of Claim and Release form in accordance with the instructions contained herein, sign it before a notary public, attach all documents required by the form, and mail the completed form to the address indicated below on or before the date indicated below.

Members of this Settlement Class include: Only those persons who can show that they paid money for membership in Lully's Inc. d/b/a/ The Right One between March 26, 2008 and March 7, 2013.

If think that you qualify as a Member of this Settlement Class, please complete this form and mail to the address listed at the bottom.

For you to be eligible for distributions from the Class settlement, you must complete this form in its entirety and return it with all supporting documents showing the amounts you paid for membership in The Right One between March 26, 2008 and March 7, 2013. This Form and all supporting documentation must be returned and postmarked by May 23, 2014.

I acknowledge that I am bound by and subject to the terms of all judgments and orders that have been or may be entered in this action concerning claims against The Right One. I agree to furnish additional to support my claim if required to do so.

RELEASE

I, the undersigned, hereby attest that I am a Member of the Settlement Class described above and that the information provided above is true and correct to the best of my knowledge. I fully release and discharge Lully's Inc. d/b/a/ The Right One, its officers, directors, managers, members, shareholders, employees, agents, successors, assigns, indemnitors, and attorneys, and all related parties that participated in this settlement (the "Released Persons"), from all claims or causes of action of any nature whatsoever (the "Claims") that have been or could have been asserted in any court or forum based upon in any way relating to the Membership and/or services proved or action performed by Lully's Inc. d/b/a The Right One or any representations made by any of its employees, officers, agents, or assignees. In this regard, I also acknowledge the following:

A. I may not know of the existence of some facts that may be relevant to any Claims, and that if such information were known to me, it could change my decision to execute this Release. I nonetheless freely assume this risk in agreeing to release, relinquish and discharge all the foregoing specified Claims, known and unknown, against the Released Persons.

B. I agree and consent to the dismissal with prejudice of all Claims asserted by me or on my behalf. I have no right to assert again any of the claims against any Released Person in any court or tribunal.

C. I agree and acknowledge that this release does not limit the scope or application of the release and extinguishment of claims contained in any judgment entered herein pursuant to the above-referenced settlement. I agree and acknowledge that I am subject to any such judgment.

D. This Release shall be of no force or effect unless and until the Court approves the Settlement, the Settlement becomes effective by its terms, the Court enters the judgment contemplated by the Settlement, and such judgment becomes final and non-appealable.

E. I warrant and represent that I have not assigned or transferred or purported to assign or transfer, voluntarily or involuntarily, any claim or matter released pursuant to this Release or any part or portion thereof.

F. I warrant and represent that the factual information that I have supplied above in the Proof of Claim section of this instrument is true and correct.
